For over 50 years, Legal Aid Chicago has provided free civil legal assistance to people living in poverty in metropolitan Chicago. Each year our attorneys, volunteers, and staff help resolve civil legal problems, including domestic violence, consumer fraud, and unfair evictions. Legal Aid Chicago was founded on the philosophy that all individuals are entitled to quality civil legal representation, regardless of their income. We work to ensure that poverty is not an impediment to justice by dismantling the legal barriers that perpetuate inequality. Legal Aid Chicago staff live our mission through our core values of equity, excellence, inclusion, kindness, and respect.

Position: Legal Aid Chicago is hiring two full time staff attorneys in the Volunteer Services Unit (VSU). VSU supports and advances Legal Aid Chicago's mission by recruiting volunteers and developing, managing, and improving pro bono focused projects. VSU also provides support to and recognition of volunteer contributions to Legal Aid Chicago.

VSU also serves clients with barriers to employment, education, or housing who seek to have their criminal record expunged, sealed, or vacated, or with alternative forms of criminal record relief such as certificates of good conduct and healthcare waivers. The staff attorneys will be involved in all aspects of criminal records relief, including records research, eligibility determinations, preparing and filing paperwork, and appearing in court. The staff attorneys will provide supervision and support to volunteers who participate in criminal records relief.

Responsibilities:

- Provide comprehensive legal representation to clients in criminal records relief matters including filing petitions and appearing in court on matters involving expungement, sealing, and motions to vacate
- Recruit, train, and support volunteer attorneys in providing representation in criminal records relief and other subject matters, as necessary
- Organize, attend, and assist with the operation of expungement legal clinics (virtual and in-person), including the supervision of volunteer attorneys
- Attend and assist with the operation of monthly general legal clinics, virtually or in-person, as necessary
- Engage in community outreach to educate members of the public regarding criminal records relief

- Establish and maintain relationships with community organizations that provide services to individuals with criminal records
- Maintain case files and timekeeping in electronic case management system
- Track data related to pro bono work and assist on related reporting
- Other duties as assigned

Qualifications:

- Applicants must have a J.D. degree and be licensed to practice law in Illinois, licensed in another state and able to waive into the Illinois bar, or be registered for the July 2021 Illinois bar exam
- Experience in criminal records relief is preferred
- Strong oral and written communication skills, highly developed organizational skills, and great client counseling skills
- Experience coordinating volunteers and organizing and implementing trainings is preferred. Enthusiasm for working with volunteers and confidence in speaking to groups of professionals necessary
- Availability during evening hours on days when clinics are held is required

Salary: Commensurate with experience. Legal Aid Chicago offers a comprehensive benefits package, including 100% employer-paid health plan options, employer-provided group life and long-term disability insurance, low-cost fitness center access, generous paid time off, and much more.
