**TEMPORARY PARALEGAL**  
**VOLUNTEER SERVICES UNIT (1 position) AND CONSUMER PRACTICE GROUP (2 positions)**  
**(Internal and External)**

For over 50 years, Legal Aid Chicago has provided free civil legal assistance to people living in poverty in metropolitan Chicago. Each year our attorneys, volunteers, and staff help resolve civil legal problems, including domestic violence, consumer fraud, and unfair evictions. Legal Aid Chicago was founded on the philosophy that all individuals are entitled to quality civil legal representation, regardless of their income. We work to ensure that poverty is not an impediment to justice by dismantling the legal barriers that perpetuate inequality. Legal Aid Chicago staff live our mission through our core values of equity, excellence, inclusion, kindness, and respect.

**Position:** Legal Aid Chicago is hiring 3 temporary paralegals in the Volunteer Services Unit and Consumer Practice Group. This position is temporary until December 31, 2021.

Paralegals work alongside attorneys and directly with clients on legal issues. This position will support our work with the Early Resolution Program with Cook County Legal Aid for Housing and Debt (CCLAHD), a county-wide initiative to help resolve eviction, foreclosure, debt, and tax deed issues.

The Early Resolution Program for evictions and consumer debt provides limited assistance to tenants and debtors in Cook County in order to advise them of their rights, provide referrals, and assist them in reaching agreements with their landlord or creditor. The program has both a pre-court and in-court component. The pre-court assistance focuses on screening and advising tenants and debtors of their rights. The in-court assistance focuses on advice, referrals and negotiation to resolve issues prior to trial. The paralegals will support both aspects of this program, providing support to staff attorneys and volunteers in screening and following up with tenants and debtors. The start date for this position is as soon as possible.

**Responsibilities:**

- Conduct telephone, virtual, and in-person (when safe to do so) interviews to determine client eligibility for services
- Assist with providing brief services to clients including providing advice, obtaining documents, sending client correspondence, assisting with court filings and communicating on behalf of client.
- Ensure smooth operations of the eviction and consumer early resolution program including client registration and volunteer support
- Engage and provide administrative support to volunteers and staff in the eviction and consumer early resolution program
- Track data related to grant, pro bono work, and assist on related reporting

**Qualifications:**

- A college degree preferred
- Computer proficiency, including familiarity with Microsoft Office applications

- Excellent interpersonal, communication, and organizational skills
- The ability to work well under pressure, and to learn and retain new information
- The ability to quickly and thoroughly gather information from clients and then summarize it concisely
- The applicant's personal background, experience, or professional background should reflect an ability to work effectively in cross-cultural situations with clients, co-workers, volunteers, and the community we serve
